Sponsorship Selection

Sign Requirements

The sign shall be approximately 2 feet by 2 feet, weather-resistant, professionally produced, and suitable for display in a public, family-oriented recreational area. The Sponsor must submit the proposed design to the Village Fiscal Officer for approval before the sign is ordered or produced. Signs may include the Sponsor's name, logo, contact information, website, slogan, and a brief description of services. Signs may not contain obscene, unlawful, defamatory, political campaign, tobacco, drug, adult-oriented, discriminatory, threatening, or misleading content. Signs may not state or imply that the Village endorses the Sponsor or its products or services.

Placement and Installation

The Village shall determine the final placement and installation method. The Sponsor may not install, move, alter, or remove the sign without Village permission. The Village may relocate or temporarily remove the sign for maintenance, construction, safety, recreational programming, special events, or other operational reasons. This Agreement grants only temporary permission to display a sign. It is not a lease and does not give the Sponsor possession or control of Village property.

Damage and Replacement

The Village shall exercise reasonable care but is not responsible for ordinary weathering, fading, vandalism, theft, storm damage, or other damage outside its reasonable control. The Village may remove any sign that becomes damaged, unsafe, illegible, or noncompliant. The Sponsor may be responsible for replacement costs.

Termination and Refunds

The Village may terminate this Agreement and remove the sign for nonpayment, violation of this Agreement, prohibited content, false information, safety concerns, or lawful Village operational needs. Sponsorship fees are generally nonrefundable after the Village has ordered, produced, or installed the sign. If the Village permanently removes the sign for reasons unrelated to the Sponsor, the Village may provide a prorated refund, an extended term, or another approved location.

No Village Endorsement

Display of the sign does not constitute an endorsement, recommendation, partnership, or guarantee by the Village of South Zanesville. The Village does not guarantee attendance, visibility, uninterrupted display, or advertising results.

Public Records

The Sponsor understands that this Agreement, the approved sign design, and related records may be subject to disclosure under Ohio public-records law.
